



INVITATION TO BID

NOTICE IS HEREBY GIVEN that the **LONG BEACH UNIFIED SCHOOL DISTRICT**, acting by and through its Governing Board, hereinafter referred to as "District", will receive sealed bids for the following project(s):

BID NO.: FAC01-1920 STEPHENS MS SITE IMPROVEMENTS

SCOPE OF WORK: Provide all labor, materials, and equipment for the demolition of two (2) existing modular buildings, and utility connections, asphalt grading for ADA compliance, new fire alarm system for six (6) new portable buildings furnished and installed by District. Work to also include minor ADA upgrades to path of travel, parking lot and existing restroom portables in surrounding area, per the bid plans and specifications.

ESTIMATED PROJECT COST: \$300,000

MANDATORY PRE-BID MEETING AND SITE VISIT: A pre-bid meeting will be held on **May 22, 2019 at 10:00 am** in **Conference Room A** at the **District's Purchasing and Contracts Branch located at 2201 E. Market St., Long Beach 90805**. There will be a visit to the project site immediately following the meeting. Attendance at the pre-bid meeting and visit to the site is **MANDATORY**.

AWARD: This contract will be awarded to the lowest responsible, responsive bidder.

DISTRICT ALLOWANCE: A District allowance of \$30,000 must be added to your bid amount.

PROJECT DURATION: 90 consecutive calendar days.

LICENSE REQUIREMENTS: At the time bids are submitted, each bidder shall possess a valid class **B** contractor's license and must maintain the licenses throughout the duration of the project.

BID SECURITY: A Bid Security of 10% of total bid amount is required to be submitted with bid form. Successful Bidder will be required to furnish 100% Payment and Performance Bonds.

The successful Bidder may substitute securities for any monies withheld by the District to ensure performance under the Contract, in accordance with the provisions of section 22300 of the Public Contract Code.

PREVAILING WAGES: The successful Bidder and its subcontractors shall pay all workers on the Project not less than the general prevailing rate of per diem wages and the general prevailing rate for holiday and overtime work as determined by the Director of the Department of Industrial Relations, State of California, for the type of work performed and the locality in which the work is to be performed within the boundaries of the District, pursuant to sections 1770 et seq. of the California Labor Code. Prevailing wage rates are available from the District or on the Internet at: www.dir.ca.gov. Bidders and Bidders' subcontractors shall comply with the registration and qualification requirements pursuant to sections 1725.5 and 1771.1 of the California Labor Code.

REQUEST FOR INFORMATION (RFI): All questions are to be submitted through Planet Bids only and will be due on **May 29, 2019 at 12:00 pm**. Any RFI submitted in any other format or in any other method shall go unanswered.

BID OPENING: Sealed bids must be received prior to **12:00 pm on June 12, 2019** at the **District's Purchasing & Contracts Branch located at 2201 E. Market St., Long Beach 90805** at which time the bids will be opened and publically read aloud. Bids shall be on the form provided by the District and each bid must conform and be responsive to the Contract Documents as defined in the General Conditions. Any bid submitted after this time shall be non-responsive and returned to bidder.
