



## REQUEST FOR INFORMAL BIDS

**NOTICE IS HEREBY GIVEN** that the **LONG BEACH UNIFIED SCHOOL DISTRICT**, acting by and through its Governing Board, hereinafter referred to as "District", will receive sealed bids for the following project(s):

### **BID NO.: FAC03-1920 ROGERS MIDDLE SCHOOL SITE IMPROVEMENTS**

**SCOPE OF WORK:** Provide all labor, materials, and equipment to remove, salvage, store and reset existing playground equipment, benches, appurtenances, storage containers and bins, according to the drawings, specifications, and directions issued by the District. Safely dispose of superseded equipment. Install new District-furnished playground equipment. All work to be completed according to current District standards.

**ESTIMATED PROJECT COST: \$150,000**

**NON-MANDATORY PRE-BID MEETING AND SITE VISIT:** A non-mandatory pre-bid meeting will be held on **June 7, 2019 at 10:00 am** in **Conference Room A** at the **District's Purchasing and Contracts Branch located at 2201 E. Market St., Long Beach 90805**. There will be a visit to the project site immediately following the meeting. Attendance at the pre-bid meeting and visit to the site is non-mandatory.

**AWARD:** This contract will be awarded to the lowest responsible, responsive bidder.

**DISTRICT ALLOWANCE:** A District allowance of **\$15,000** must be added to your bid amount. See bid form for more information.

**PROJECT DURATION:** **39** consecutive calendar days.

**LICENSE REQUIREMENTS:** At the time bids are submitted, each bidder shall possess a valid class **B** contractor's license and must maintain the license(s) throughout the duration of the project.

**BID SECURITY:** A Bid Security of 10% of total bid amount is required to be submitted at the time of bid submission with the bid form. Successful Bidder will be required to furnish 100% Payment and Performance Bonds.

The successful Bidder may substitute securities for any monies withheld by the District to ensure performance under the Contract, in accordance with the provisions of section 22300 of the Public Contract Code.

**PREVAILING WAGES:** The successful Bidder and its subcontractors shall pay all workers on the Project not less than the general prevailing rate of per diem wages and the general prevailing rate for holiday and overtime work as determined by the Director of the Department of Industrial Relations, State of California, for the type of work performed and the locality in which the work is to be performed within the boundaries of the District, pursuant to sections 1770 et seq. of the California Labor Code. Prevailing wage rates are available from the District or on the Internet at: [www.dir.ca.gov](http://www.dir.ca.gov). Bidders and Bidders' subcontractors shall comply with the registration and qualification requirements pursuant to sections 1725.5 and 1771.1 of the California Labor Code.

**REQUEST FOR INFORMATION (RFI):** All questions are to be submitted through Planet Bids only and will be due on **June 11, 2019 at 2:00 pm**. Any RFI submitted in any other format or in any other method shall go unanswered.

**BID DEADLINE & OPENING:** Sealed bids must be received prior to **2:00 pm on June 18, 2019** at the **District's Purchasing & Contracts Branch located at 2201 E. Market St., Long Beach 90805** at which time the bids will be opened and publicly read aloud. Bids shall be on the form provided by the District and each bid must conform and be responsive to the Contract Documents as defined in the General Conditions. Any bid submitted after this time shall be non-responsive and returned to bidder. The District reserves the right to reject any or all bids or to waive any irregularities or informalities in any bids or in the bidding.
