



## INVITATION TO BID

**NOTICE IS HEREBY GIVEN** that the **LONG BEACH UNIFIED SCHOOL DISTRICT**, acting by and through its Governing Board, hereinafter referred to as "District", will receive sealed bids for the following project(s):

**GARFIELD ES - KITCHEN HOOD**

**A NON-MANDATORY Pre-bid Conference and Site Visit** will be held on **Monday, January 14, 2019 at 10:00 am** at the District's Purchasing Branch located at 2201 E. Market Street, Long Beach, CA 90805

**SCOPE OF WORK:** Provide all labor, materials and equipment required to demo existing kitchen hood and install new kitchen hood at Garfield Elementary School, per the bid plans and specifications.

**AWARD:** This project is to be awarded to the lowest responsible, responsive bidder based on the base bid amount

**PROJECT DURATION:** 54 consecutive calendar days.

**LICENSE REQUIREMENTS:** At the time bids are submitted, each bidder shall possess a valid **Class B** contractor's license and must maintain the licenses throughout the duration of the project.

**ESTIMATED COST:** \$150,000 - \$200,000

**BID OPENING:** Sealed bids must be received prior to **2:00 pm on January 30, 2019** at the **Purchasing Branch located at 2201 E. Market Street, Long Beach, CA 90805** at which the bids will be opened and publically read aloud. Bids shall be on the form provided by the District and each bid must conform and be responsive to the Contract Documents as defined in the General Conditions. Any bid submitted after this time shall be non-responsive and returned to bidder.

**PREVAILING WAGES:** The successful Bidder and its subcontractors shall pay all workers on the Project not less than the general prevailing rate of per diem wages and the general prevailing rate for holiday and overtime work as determined by the Director of the Department of Industrial Relations, State of California, for the type of work performed and the locality in which the work is to be performed within the boundaries of the District, pursuant to sections 1770 et seq. of the California Labor Code. Prevailing wage rates are available from the District or on the Internet at: [www.dir.ca.gov](http://www.dir.ca.gov). Bidders and Bidders' subcontractors shall comply with the registration and qualification requirements pursuant to sections 1725.5 and 1771.1 of the California Labor Code.

**BID SECURITY:** A Bid Security of 10% of total bid amount is required to be submitted with bid form. Successful Bidder will be required to furnish 100% Payment and Performance Bonds.

The successful Bidder may substitute securities for any monies withheld by the District to ensure performance under the Contract, in accordance with the provisions of section 22300 of the Public Contract Code.
