NOTICE IS HEREBY GIVEN that the LONG BEACH UNIFIED SCHOOL DISTRICT, acting by and through its Governing Board, hereinafter referred to as "District", will receive sealed bids for the following project(s):

SCOPE OF WORK: Provide all labor, materials, equipment and incidentals for the installation of an intercom (PA)/clock and speaker system at Jordan High School, per bid plans and specifications.

ESTIMATED PROJECT COST: \$400,000

PROJECT DURATION: 150 consecutive calendar days.

LICENSE REQUIREMENTS: At the time bids are submitted, each bidder shall possess a valid class C-7 or C-10 contractor's license and must maintain the license(s) throughout the duration of the project. Installation of ICS system to be provided by a certified Three-Sixty Galaxy installer.

SITE VISIT/JOB WALK: A MANDATORY site visit will be held on August 28, 2020 at 10:00am. To attend the site visit, please reserve your attendance by sending an email to Contracts@LBSchools.net. A confirmation email will be sent to you. No more than one (1) person per firm will be allowed to attend due to current restrictions. All current health & safety protocols shall be followed. Only groups of ten (10) bidders at a time will be allowed to walk the project, and will be scheduled accordingly that day. Bidders shall not visit the project site without an authorized District Representative present.

REQUEST FOR INFORMATION (RFI): All questions are to be submitted through Planet Bids only. Any RFI submitted in any other format or in any other method shall go unanswered.

BID SUBMISSION: Bids are to be submitted and uploaded electronically via the District's Online Vendor Portal on PlanetBids on or before 2:00 PM on September 10, 2020. Bidder assumes full and sole responsibility for timely receipt of its Bid and any other documents required to be submitted with the Bid, by the District at the Online Vendor Portal.

NOTE: Pushing the submit button on the electronic system may not be instantaneous; and may take time for the Bidder's documents to upload and transmit before the Bid is accepted. It is the Bidder's sole responsibility to ensure their document(s) are uploaded, transmitted, and arrive in time electronically. Once a Bidder's Bid is successfully uploaded to the Online Vendor Portal the Bidder will receive a five (5) digit "VBID" electronic confirmation number. This number should be recorded as proof of submission of your bid. If the Bidder does not receive an electronic confirmation "VBID" number the Bidder's upload was not successful or was electronically received after the Bid date / time. The District is not responsible for Bids that are received after the deadline noted above no matter the reason. In the event of a conflict between any of the provisions of the Online Vendor Portal and the bid documents, the provisions in the bid documents shall control. Bidders are required to upload the mandatory bid submission forms per the checklist provided in the bid document. Missing documents may cause your bid to be deemed non-responsive.

AWARD: This contract will be awarded to the lowest responsible, responsive bidder.

DISTRICT ALLOWANCE: A District allowance of **\$40,000** for unforeseen circumstances, will be added to the awarded contract. See bid form for more information.

BID SECURITY: A Bid Security of 10% of total bid amount is required to be submitted with bid form. Successful Bidder will be required to furnish 100% Payment and Performance Bonds. The successful Bidder may substitute securities for any monies withheld by the District to ensure performance under the Contract, in accordance with the provisions of section 22300 of the Public Contract Code.

PREVAILING WAGES: The successful Bidder and its subcontractors shall pay all workers on the Project not less than the general prevailing rate of per diem wages and the general prevailing rate for holiday and overtime work as determined by the Director of the Department of Industrial Relations, State of California, for the type of work performed and the locality in which the work is to be performed within the boundaries of the District, pursuant to sections 1770 et seq. of the California Labor Code. Bidders and Bidders' subcontractors shall comply with the registration and qualification requirements pursuant to sections 1725.5 and 1771.1 of the California Labor Code.
